



25th International Postgraduate Research Conference (IPRC) 2025

Guidelines for Abstract Preparation

The authors should adhere to the abstract format given below. Failure to follow these guidelines may result in the rejection of your abstract by the Editorial Board of the International Postgraduate Research Conference (IPRC) - 2025.

Abstracts should only be from original research. Concepts, Future Studies and Reviews are not accepted.

Page setting format (Layout):

➤ Paper size: A4 (210 x 297 mm) typed single-sided only

Font: Cambria

Font size: 12

Line spacing: 1.0

Text alignment: Justify

➤ Margins: 2.5 cm (1") on all sides

➤ Word count: Maximum of 300 words

Formatting guidelines:

Academic Track of the Abstract – Should be on the top right-hand corner of the abstract. (Font: Cambria ,10, Align Right, *Italic*)

Eg: Multidisciplinary Studies

Title of the Abstract: (Font: Cambria, 14, Bold, Centered). Title should be brief, descriptive, and should not span more than 2 lines. Capital letters should be used only for the first letter in the first word of the title, scientific names and proper nouns. Abbreviations should not be used.

Eg: The impact of work stress on job satisfaction and sleep quality for couriers in China: the role of psychological capital









Text/Body of the Abstract: A concise and factual abstract is required. An abstract is a single paragraph, without subheadings, indentation, or references. It should be an explicit summary of your presentation that states the research problem, the objectives, the methods used, and the major results and conclusions. Do not include bullets/lists or references in the abstract. Use only the SI units (eg. kg m⁻³ not as kg/m³). Chemical formulae should be written in a standard form such as "K₂SO₄", not as "K2SO₄". Use a zero before decimal points such as "0.45," not ".45." All scientific names should be italicized. Both genus and species names should be mentioned at the first appearance, and only the species name can be mentioned with the abbreviated genus name subsequently. All non-English terms should be italicized (e.g., et al., viz., in vivo, in vitro, ad libitum, de novo, Hambanthota, Yala) The abstract should be between 250 and 300 words long and justified. (Font: Cambria, 12) The use of non-standard or uncommon abbreviations and references should be avoided. Keywords should be given leaving one-line space below this text. (Font: Cambria, 12, Left Aligned)

Keywords: Three to five keywords or phrases in alphabetical order, separated by commas.

Eg: Keywords: Social media, Blockchain, Sharding techniques, Consensus mechanisms, Blended learning

References, tables, or figures should not be included in the abstract.

Before submitting the abstract make sure the guideline texts are removed from the template.

For abstracts written in English: Use United States (US) English. However, both US and UK English should not be written in a single article.

Non-English terms: All non-English terms should be *italicized* (*e.g., et al., viz., in vivo, in vitro, ad libitum, de novo, Hambanthota, Yala*)

All scientific names should be *italicized*. Both genus and species names should be mentioned at the first appearance and only the species name can be mentioned with the abbreviated genus name subsequently.

Eg: *Clostridium botulinum* and subsequently *C. botulinum*

Software: Microsoft Word (the template has been provided at the end of these guidelines and can be downloaded from the https://conf.kln.ac.lk/iprc/index.php/guidelines/author-guidelines)

Accepted abstracts will be published online in the Conference Proceedings - International

Postgraduate Research Conference (IPRC) - 2025 as the online version after the presentations. In

addition, the abstracts will be deposited in the university e-repository for wider exposure. The

papers, not presented by the authors will be removed from the final version of the conference

proceedings.

All submissions should be made electronically through the online abstract submission

system, Microsoft's Conference Management Toolkit (CMT). More details can be found on

the IPRC conference website (https://conf.kln.ac.lk/iprc/index.php). Abstracts that are

not submitted through CMT will be rejected.

between the authors' names and the affiliations. When there are more than two or more authors

and if they are from different institutions their affiliations should be identified by superscript

Arabic numbers (see the template and example). Identify the corresponding author by an asterisk

(*). The e-mail address of the corresponding author should be indicated left aligned below the
